Agreement for Using Space at the Family Resiliency Center

(Less than 3 months)

1. Purpose

The purpose of this Agreement is to establish the terms and conditions under which ______ (the "User") may access and use the open shared space provided by First 5 San Benito.

2. Access and Use

2.1 Permission: First 5 San Benito grants the User permission to access and use the open shared space located at 351 Tres Pinos Road Hollister CA 95023.

2.2 Duration: This Agreement shall be effective from [_____] to [____]

2.3 Conditions: The User agrees to use the open shared space in accordance with all applicable laws and regulations as well as First 5 San Benito's reasonable instructions and requirements for security of the facility. The space shall be used for the purposes specified below only.

2.4 Cleaning Fee and Deposit for Incidentals:

If the space is to be shared regularly for less than three months, a cleaning fee of \$14 dollars for less than 4 hours and \$28 for over 4 hours for each session will be applicable.

Additionally, a deposit of 300.00 will be required. The deposit will be returned to the User at the end of the term, without any reasonable deductions for damage to the premises.

- 3. Responsibilities
- 3.1 User Responsibilities:

The User is responsible for maintaining the cleanliness and orderliness of the space during use.

Any damage caused to the property during use shall be the responsibility of the User.

The User shall maintain a sign-in sheet for all individuals accessing the space showing names, ages, email addresses, and times of access. Copies of sign-in sheets shall be provided to First 5 San Benito upon request.

3.2 Purpose/Intent of Usage:

4. Term and Renewal

The liability policy shall name First 5 San Benito as an additional insured and User will provide First 5 San Benito with a certificate of insurance establishing this insurance.

6. Indemnification

The User agrees to indemnify, defend, and hold First 5 San Benito harmless from any claims, injuries, losses, or damages arising out of the User's use of the open shared space except those injuries, losses, or damages are solely the result of First 5 San Benito's sole negligence

7. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of California.

8. Miscellaneous

8.1 Amendments: Any amendments to this Agreement must be made in writing and agreed upon by both parties.

8.2 Notices: All notices under this Agreement shall be in writing and delivered to the addresses specified by each party by written notice.
